Introduction

The Department of Natural and Cultural Resources and the staff and Board of Trustees of the North Carolina Land and Water Fund (NCLWF) thank the members of the General Assembly of North Carolina for their continued and substantial commitment to protect safe and clean drinking water, natural and cultural resources, and the U.S. military mission within North Carolina. NCLWF hereby presents its annual report to the General Assembly and the public, pursuant to NCGS 143B-135.244.

Background

The 1996 General Assembly created the Clean Water Management Trust Fund (now known as the NC Land and Water Fund) [NCGS 143B-135.230 et seq.], "to clean up pollution in the State's surface waters and to protect, preserve and conserve those waters that are not yet polluted." As originally created, NCLWF was to "use innovative and non-regulatory approaches to help finance projects that specifically address water pollution problems and focus on upgrading surface waters, eliminating pollution, and protecting, preserving and conserving unpolluted surface waters, including enhancement or development of drinking water supplies" and "to build a network of riparian buffers and greenways for environmental, educational, and recreational benefit." In 2013, the statutory purposes of NCLWF were amended to include protection of lands with natural, cultural, and historic value. In 2019, per Senate Bill 381, the Clean Water Management Trust Fund was directed to begin doing business as the "North Carolina Land and Water Fund."

From its inception through 2022, through appropriations and receipts, NCLWF has partnered with State agencies, local government units, and nonprofit organizations to contribute over \$1 billion to the protection and restoration of the State's natural and cultural resources. Further, the Fund has leveraged approximately \$1.7 billion in additional funds to support those same efforts to protect and restore our State's resources. These leveraged funds come from private individuals, nonprofits, corporations, and local, State and Federal government agencies, including Department of Defense/military funds.

Administration


NCLWF is in the Department of Natural and Cultural Resources and housed in the Nature Research Center (NRC) building on Jones St. in Raleigh, NC. Will Summer was hired as Executive Director in January 2022. Summer has worked for NCLWF since 2008, serving as Deputy Director since 2017 and Interim Director beginning in June 2021. NCLWF is within DNCR's Division of Land and Water Stewardship, for which Summer also serves as Director. The Division reports to DNCR Deputy Secretary for Natural Resources Jeff Michael. NCLWF is supported by a staff of 10, including the Executive Director. For additional information, see Attachment 1 – *Organizational Chart.* Administration/operations funds of up to \$1,250,133 were appropriated in the FY 22-23 budget.

As of November 1, 2022, NCLWF staff is managing 163 active grants totaling over \$78.5 million dollars. To ensure a high level of due diligence in monitoring grants and expending funds, staff has developed a transparent process with clearly communicated expectations. Staff is always available to provide technical assistance and other resources to guide recipients through grant requirements and successful project implementation.

Grant Funding

Legislative Appropriation


The 2021 State Budget contained a substantial increase for NCLWF, including \$11,000,000 and \$14,000,000 nonrecurring increases for 2021 and 2022, respectively. There was also a \$37,500,000 nonrecurring increase in each year from the State Capital Infrastructure Fund (SCIF). The 2022 State Budget further improved upon the 2021 budget by making \$11,000,000 of the previous year's nonrecurring appropriations recurring. The annual appropriations for the last five years are shown in the graph below (figure 1).

Other Revenue

In addition to legislative appropriations, NCLWF receives a dedicated revenue stream from automobile license plate fees. These fees generate approximately \$5 million annually (\$10 from each First in Forestry plate, \$15 from each Out of State Collegiate plate, and \$15 for each Personalized plate). As of November 15, \$2,438,083.50 has been collected in FY 22-23. All of these funds are used for grants. Revenue generated from license fees for the last five years is shown on the graph below (figure 2).



2021 Summary (Revised)

The 2021 Annual Report was submitted before the passage of the 2021 State Budget, which contained additional nonrecurring funds. The NCLWF Board met in December 2021 and awarded additional grants with those funds. The updated information follows.

For FY 2020-2021, NCLWF received 144 grant applications totaling \$82,613,060. The Board of Trustees awarded 91 grants totaling \$60,537,964 for the 2021 funding cycle. Table 1 below shows a breakdown of the program areas with total amounts funded for FY 2021-22. 2022 Summary

In 2022, NCLWF received 195 grant applications totaling \$177,334,169. In September, the Board of Trustees awarded 123 grants totaling \$70,489,554 for the 2022 funding cycle. Table 2 below shows a breakdown of the program areas with total amounts funded as of November 15. As required by G.S. § 143B-135.244, a detailed list of grant awards for the previous 12-month period is provided as Attachment 3 – 2022 Grant Cycle Awards to Date at the end of this report.

Impacts

NCLWF marked its 26th anniversary in 2022. Since its inception, more than 500,000 acres of beautiful North Carolina land have been conserved and more than 3,000 miles of streams protected. However, NCLWF protects more than the State's natural and cultural resources. Grants from the program support major North Carolina economies including agriculture, tourism, fisheries, hunting, forestry, and the military. Funds also help meet infrastructure needs of municipalities and increase recreational opportunities by supporting parks, trails, and greenways, enhancing the health and quality of life for North Carolina citizens. North Carolina's quality of life is the foundation for sustainable economic investment and development.

The funds for 2022 will be used to protect 27,157 acres and restore or enhance over 36 miles of the State's waterways, including trout waters, coastal habitats, greenways and trails, and buffers around military bases. Over 20,998 acres will be open to the public for hiking, hunting, boating, birding and other recreational uses.

Funds were also granted for 37 projects to restore streams, rivers and estuaries, and four projects designed to evaluate innovative techniques for managing stormwater. In addition, eight planning projects were funded to identify key water quality and conservation opportunities in mountain, piedmont, and coastal watersheds. Grants awarded this year will help protect 166 types of rare plants, animals, and natural communities, including 55 plants and animals that are threatened or endangered.

In 2022, NCLWF funded projects that:

- Support outdoor recreation activities, which account for \$3.3 billion of NCNC's annual economy, by:
 - Protecting over 10,000 acres to be added to NC Wildlife Resources Commission game lands in Ashe, Bertie, Bladen, Cherokee, Gates, Graham, Halifax, Jackson, Macon, Madison, Pamlico, Pender, Wilkes, and Yancey counties;
 - Adding over 5,000 acres to NC State Parks in Bladen, Harnett, Orange, Robeson, Wake, Watauga, and Yancey counties;
 - Protecting over 7,000 acres in local parks and preserves in Ashe, Buncombe, Burke, Caldwell, Carteret, Chatham, Craven, Gaston, Graham, Henderson, Hyde, Macon, Mitchell, Montgomery, New Hanover, Pender, Polk, Transylvania, Wake, and Wilkes counties;
 - Protecting 15 sites with historic and cultural resources such as the Valle Crucis Historic District, the Seabreeze Beach Resort site, Occoneechee Speedway and archaeological sites, as well as buffers to the Blue Ridge Parkway, Overmountain Victory Trail, and Trail of Tears National Historic Trail;
 - Enhancing sport fisheries across the state, including trout waters in Ashe, Buncombe, Caldwell, Graham, Jackson, Macon, Mitchell, Transylvania, Watauga, Wilkes and Yancey counties, Muskellunge habitat in Henderson and Transylvania counties, and saltwater fisheries in New Hanover County;
 - Funding shoreline protection and river access stabilization projects at popular recreational locations from Jockey's Ridge State Park in Dare County to the New River State Park in Ashe County; and
 - Funding planning grants across North Carolina, including efforts to identify wetlands and floodplains capable of mitigating flooding, identifying threats to water supplies and fishing spots on the Rocky River near Siler City, reducing nonpoint source pollution to recreation areas of the South Fork Catawba River, and addressing flooding issues in multiple NC towns including Boone, Canton, Smithfield, and Washington.
- Buffer military installations and training areas, assisting a sector that comprises over 12% of NC's economy, awarding \$5.5 million and protecting over 6,200 acres near MCAS New River Air Station, MCAS Cherry Point, US Army Fort Bragg, USAF Seymour Johnson, and USMC Camp Lejeune.
- Add resources to rural and economically distressed areas, including:
 - \$18.4 million in grants to Tier 1 counties
 - \$22.8 million in grants to Tier 2 counties

Selected Project Highlights

2022-007 Carolina Beach - Freeman Park (New Hanover County) - The Town of Carolina Beach will protect approximately 337 acres along the Intracoastal Waterway and Carolina Beach Inlet. The project will provide public access while protecting the site of the former Seabreeze Beach Resort, one of very few recreational beaches open to African Americans during segregation in the southeast.

2022-030 - Eno River Association - Historic Occoneechee Speedway (Orange County) - The Eno River Association will protect approximately 226 acres along the Eno River and Cates Creek, connecting downtown Hillsborough to Eno River State Park via the existing Mountains-to-Sea Trail and Riverwalk. Several archaeological sites associated with indigenous villages dating from 1,000 AD through the late 17th century will also be protected, as will the Occoneechee Speedway dirt track, now listed on the National Register of Historic Places.

2022-039 – Mainspring Conservation Trust - Amazing Grace Complex - Big Ridge (Jackson County) - Mainspring Conservation Trust will purchase approximately 900 acres along Dickson, Bear, and Canoe Creeks, containing a portion of High Top Mountain and Lizzie Mountain natural areas. The Amazing Grace Complex properties have long been a high priority for conservation organizations working in the area.

2022-052 - NC Botanical Gardens Foundation - Raney - Stillhouse Bottom (Orange County) -The NC Botanical Garden Foundation will purchase approximately 25 acres along Stillhouse Branch containing a portion of Morgan Creek Bluffs natural area. This will expand the Stillhouse Bottom Nature Preserve and provide public access for hiking.

2022-069 – NC Wildlife Resources Commission - Snelson Access Tract - Sandy Mush Game Land (Madison County) - The NC Wildlife Resources Commission will purchase approximately 72 acres protecting Sandy Mush Creek and a portion of Sandy Mush Creek/Turkey Creek Gorge natural area. This project will expand the Sandy Mush Game Land and provide the first public access to this game land in Madison County.

2022-084 – The Conservation Fund - Lumber River State Park South (Robeson County) - The Conservation Fund will purchase approximately 3,035 acres along the Lumber River that includes all of Lumber River Swamp/Devil's Elbow and a portion of Ashpole Swamp/Flat Swamp Confluence natural areas. This expansion of Lumber River State Park will provide additional public access and protect nearly four miles of the Lumber River, a National Wild and Scenic River.

2022-091 – Piedmont Land Conservancy - Shoe Buckle Tract - Future State Forest (Stokes County) - This project will create a new Educational State Forest and provide public access, including a canoe launch on the Dan River. The recently rediscovered enslaved persons cemetery associated with the Hairston Plantation will be protected and the property also buffers the Upper Sauratown Archaeological District.

2022 Annual Report per G.S. 143B-135.244 DNCR – NC Land and Water Fund December 1, 2022 Page 6 of 23 **2022-112** – The Nature Conservancy - Sleepy Creek Farms - Holly Shelter Game Land (Pender County) - The Nature Conservancy will purchase approximately 1,625 acres including pocosin wetlands and a portion of the Holly Shelter natural area. The project will provide public access by expanding Holly Shelter Game Land and allow for relocation of a section of the Mountains-to-Sea Trail that currently follows the highway to protected land. The project is also a high priority for protection of MCAS New River Air Station operations with committed Department of Defense funds.

2022-407 – Blue Ridge RC&D - Mitchell Branch – Daylighting (Yancey County) - In the Fall of 2021, Yancey County and the Town of Burnsville received significant precipitation that caused localized flooding resulting in several sinkholes appearing along the culverted section of Mitchell Branch. This restoration project contains a 600-linear-foot section of piped culvert for Mitchell Branch that is old, degrading, and not fitted properly at connections. The project would daylight the stream in lieu of replacing the culverted section to improve flooding conditions, improve aquatic habitat and connectivity, and upgrade the town space to benefit the Town of Burnsville.

2022-425 - North Carolina Coastal Federation - Core Sound - Living Shoreline (Carteret County) - This project would construct a 1,600-foot living shoreline to protect a U.S. Army Corps of Engineers-designated Harbor of Refuge, Carteret County's newest 31-acre community open space, and a boat ramp. Restored salt marsh wetland behind the living shoreline will serve as a buffer, reducing sediment and polluted stormwater runoff from the land, decreasing turbidity and further improving coastal water quality in Cedar Island Bay and Core Sound. In addition to shoreline stabilization, the living shoreline will restore fish and oyster habitat and help improve the coastal water quality of Cedar Island Bay and Core Sound, both environmentally and economically important shellfish areas and federally designated Essential Fish Habitat.

2022-445 - The Conservation Fund - Jessup Mill - Dam Removal (Stokes County) - Jessup Mill Dam is located 50 miles upstream of the Lindsey Bridge Dam Restoration Project and is the final major fish passage barrier remaining in the Upper Dan River. Dam removal and improved fish passage at this site will restore access for the endangered Roanoke logperch to the Dan River headwaters in Virginia. The completed project will restore 2,700 feet of reservoir to flowing stream and result in over 75 miles of connection of the Dan River from the North Carolina border to the dam in Eden.

2022-446 – The Nature Conservancy - Angola Bay Game Land - Pocosin Restoration (Pender County) - This project involves the restoration of approximately 7,500 acres of drained pocosin wetlands at Angola Bay Game Land. The project scale alone will make it one of the largest, single-owner wetland restorations in NC. Restoration of these wetlands is critical to protect water quality, improve habitat, preserve natural carbon stores, and provide important storm water storage capacity.

2022-805 - HWA - Upper Pigeon River - Flood Mitigation Plan (Haywood County) - In August 2021, Tropical Storm Fred devastated many communities in Haywood and Transylvania

In the Pigeon River watershed in Haywood County, six people died and over 400 structures were destroyed or damaged, including Canton's Town Hall. The project will develop a flood reduction plan for areas of Cruso, Canton, and Clyde that are at risk for future flooding. The plan will also identify opportunities to preserve natural areas important for flood prevention, prepare projects for implementation, and conduct an economic analysis of properties eligible for flood buyout programs.

2022-810 – The Conservation Fund - Upper Rocky River - Watershed Plan (Chatham County) -The project will develop a watershed action plan and a watershed restoration and protection plan based on the EPA nine minimum element watershed plan handbook for each of these six sub-watersheds in the upper Rocky River watershed. The ultimate goal of the planning effort is to remove the receiving waters from the State's 303(d) list of impaired waters and improve aquatic habitat.

2022-1006 - NCSU - Real-Time Control of Stormwater Ponds (Wilson County) -This innovative stormwater project will evaluate the effectiveness of automating the flood preparation practice of pumping stormwater retention pools ahead of major rain events in the City of Wilson, NC to increase flood water storage. The goal is to increase retention pool capacity in an attempt to alleviate local flooding.

Flood Risk Reduction Program Update

The NC General Assembly appropriated \$15 million in the FY 2021-22 budget to the NC Land and Water Fund to establish a flood risk reduction grant program. Per the budget, these funds must be encumbered by June 30, 2023.

The Flood Risk Reduction Committee met six times beginning in January and recommended program guidelines, ranking criteria, and an implementation timeline. The full board approved the following timeline in May:

We received 61 applications totaling \$81,693,062 in requests for the phase one application. Thirty-two of the applications that were the best fit for the program were invited to complete phase two applications. Of those, we received 20 completed phase two applications totaling \$20,749,508. The Flood Risk Reduction Committee will review applications in January 2023 and the full board is scheduled to meet and approve them on February 28. Staff will execute contracts before the end of the fiscal year on June 30. We are on schedule to meet our expectations and have all \$15 million encumbered as directed.

Program and Policy Updates

Board Action

In addition to annual grant awards and creation of the Flood Risk Reduction Program, the Board of Trustees approved several updates to policies on appraisals and property management costs, and considered several small easement amendment requests. The board also allocated \$2.5 million to the Fund's stewardship endowment for older projects that did not initially have stewardship funds set aside. This is a critical step in protecting our investment in conservation agreements by ensuring that we have the resources in our endowment for annual monitoring of our projects.

Legislative Action

There was no legislative action this year that affected NCLWF other than increases in the budget.

Judicial Action

There was no judicial action this year that affected NCLWF.

Executive Action

There were no direct Executive Orders or other executive actions that affected the function of NCLWF this year.


Annual Report Summary
